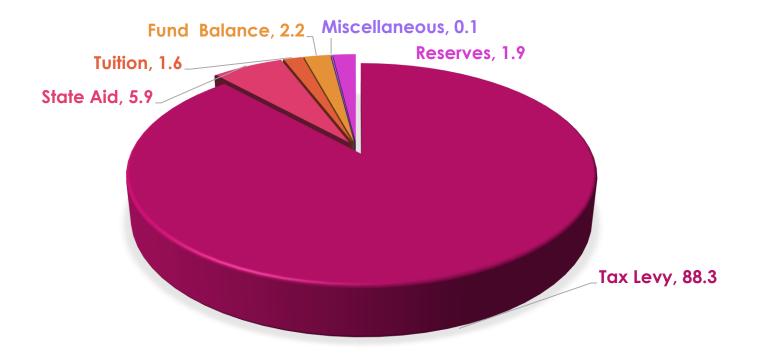

Proposed REVENUE CHART 2022-2023

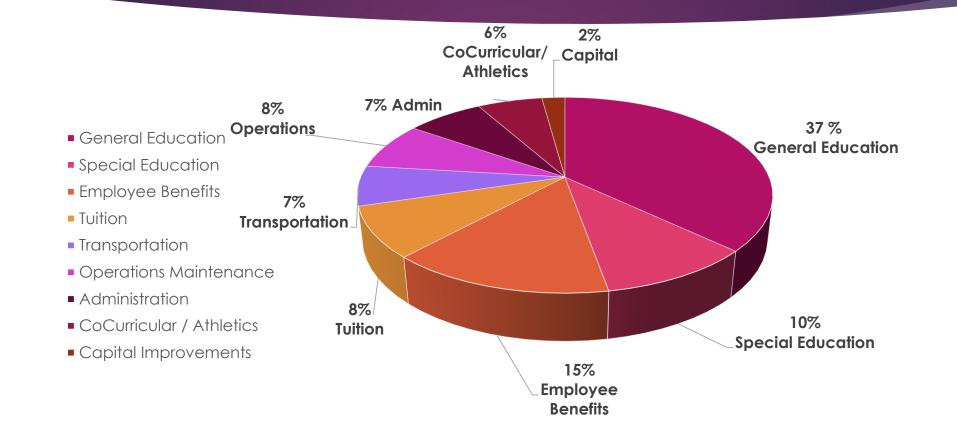
