Dear Parents and Students,

As outlined on the standardized testing letter previously sent, I'm writing to share details regarding two upcoming assessments recently required by the state: the New Jersey Student Learning Assessment (NJSLA)-Adaptive Field Test and the New Jersey Graduation Proficiency Assessment (NJGPA)-Adaptive Field Test.

These tests allow the New Jersey Department of Education to gather necessary information on new item types and test the new assessment platform's usability and functionality. They are solely for development purposes; student results will not be shared with us and will not be used for official accountability measures. The primary goal is to contribute to the fairness and accuracy of future statewide assessments.

Students will be assessed on the previous year's learning and mastery of the New Jersey Student Learning Standards. For example, a student in Grade 10 will be assessed on Grade 9 English (reading and writing) content and the Mathematics content of the class they were enrolled in last school year (2024-2025).

We will administer the tests during our regularly scheduled school days on Monday, November 10th, Wednesday, November 12th (PDW-9:15 am start time for students), and Thursday, November 13th. The chart below outlines who is required to take each assessment. Teachers will communicate more specific details with students in their classes regarding when each assessment will be administered. Students MUST bring their fully-charged RFH-issued Chromebook each day for testing and wired headphones. We will not be giving out any loaner Chromebooks for this test administration.
