Superintendent's Report at Beginning of the Hearing Report of 2008-2009

Violence (including harassment, intimidation and bullying):

There were seven incidents:

- 1. In November 2008 there was one incident of harassment involving one student harassing another student resulting in detention.
- In February 2009 there was one incident of violence which involved one student assaulting another student in the cafeteria resulting in three days of out-of-school suspension.
- 3. In March 2009 there were two incidents of harassment: one involved a student harassing another student resulting in one day of Suspension Alternative Program and the other involved a student harassing another student resulting in Saturday detention.
- 4. In April 2009 there were two incidents of harassment: one involved a student harassing another student which resulted in two days of out-of-school suspension and the other involved one student harassing another student resulting in after-school detention.
- 5. In May there was one incident of harassment which involved one student harassing another student resulting in one day of the Suspension Alternative Program.

Substance Abuse

There were six incidents involving 11 students:

- 1. In October 2008 there were two incidents: one incident involved five students being under the influence of a controlled dangerous substance in which all five students were suspended for ten days out-of-school (one student was brought for an expulsion hearing). Police were notified and charges filed on two of the students for possession of a controlled dangerous substance. The other incident involved one student being under the influence of marijuana resulting in a ten day out-of-school suspension.
- 2. In November there were two incidents: both incidents involved a student under the influence of marijuana resulting in a ten-day out-of-school suspension for both students.

- 3. In March there was one incident involving two students under the influence of alcohol at an extra-curricular event, both students received ten days of out-of-school suspension.
- 4. In June there was one incident which involved a student being under the influence of marijuana resulting in a ten day out-of-school suspension.

<u>Vandalism</u> (including theft of property):

There was one incident:

1. In March there was one incident of "damage to school property" which resulted in the student cleaning a machine in the Art Room and serving a Saturday detention.

Summary

- There were seven incidents of Violence (which includes harassment, intimidation, and bullying); one incident of vandalism, and 6 incidents of substance abuse involving 11students for a total of fourteen incidents.
- Police were notified and charges filed for one incident.
- Student was brought to an Expulsion Hearing in once incident.
- Police were notified but no complaints filed in one incident.
- There were thirteen short term suspensions (less than ten days).
- There were nineteen offenders (unduplicated total) in the fourteen incidents. Of the nineteen offenders, six were students with a disability.
- Victims were 5 regular education students and one student with a disability.

The other incident involved a student drawing obscene pictures and messages in the portfolio of a female student. The student was suspended Out of School for 5 days.

- In September of 2009 one student was found to be under the influence of marijuana during the school day and was suspended for 10 days Out of School.
- 2. In March of 2010 a student was arrested while on a school trip for possession of marijuana which resulted in a 10 day Out of School suspension.

There were no incidents of vandalism during the 2009-2010 school year.
